2014: A Breakthrough Year for KWMF 2015: Approaching the Finish Line

Looking Back: The Past Year

2014 was the most active and productive year for our Foundation since its founding in 2010. When the year began, we had received less than \$450,000 in donations, most of it from KWMF's officers, including more than \$260,000 from Treasurer Donald F. Reid and over \$110,000 from Vice President Man J. Kim. As of this date, we have raised approximately \$2.1 million. Once the pending \$1 million grant from the Korean Government is confirmed and received, we will have raised at least \$3.1 million. That will leave us still shy of – but within striking distance of – our target of \$3.48 million. 2014 has been a very successful fundraising year for KWMF.

If you have been considering making a donation but have been holding back for some reason, now is the time we need you to step forward. If you have already donated, please consider making another donation. Here are some of the highlights of 2014:

January 17: At a ceremony at the Korean Consulate General in San Francisco, KWMF Secretary and Korean War veteran John Stevens received a \$150,000 donation from Samsung Semiconductor President Charlie Young Chang Bae. Consul General Han Dong-man hosted and presided at the ceremony.

March 14: We received a donation by mail from the S.D. Bechtel, Jr. Foundation. The Bechtel people have requested that we keep the amount confidential, but the Bechtel grant remains our largest single donation to date.

April 10: At a ceremony at the Korean Consulate General in San Francisco, Chevron Corporation presented KWMF with a donation of \$25,000. The donation check was presented by Chevron Vice President Shariq Yosufzai to KWMF Treasurer and Korean War veteran Donald F. Reid. Consul General Han Dong-man hosted and presided at the ceremony.





August 26: Four senior cadets from the Korean Military Academy visited the Memorial site, after which KWMF's officers hosted a lunch for them at the Marines' Memorial Club. The cadets were eager to meet with Korean War vets. They discussed the war with John Stevens and Don Reid, and presented the veterans with gifts. The cadets expressed their gratitude, and later they also made generous donations.

He promoted his participation as a fundraiser for the Memorial. This resulted in extensive media coverage not only of Wally, but of our Memorial and its need for funding, and generated several thousand dollars in donations.

Looking Ahead: The Coming Year

We've come a long way, but our task is far from over. Our primary challenges in 2015 will be as follows:

- Finish the Fundraising: We need to raise the remaining funds required to complete the Memorial and provide for long-term maintenance. This is going to take a concerted effort on the part of all of us, because the prevailing wisdom among fundraising professionals is that the final funds are historically the most difficult to raise. This has proven to be the case for KWMF: the level of donations has fallen off significantly in recent weeks. In addition, we seem to be running out of corporations and foundations, both here and in Korea, that would even consider making a donation for a Memorial to this so-called Forgotten War. In dozens of instances, our requests for donations have been met with apathy or indifference, and all too often simply ignored.
- Accelerate the Timetable: We need to continue to do everything we can, within reason, to speed up the construction schedule for the Memorial.
- Stage a High-Profile June 25 Groundbreaking Ceremony: We need to make a strong public statement of our commitment to our donors and to all Korean War veterans living and dead. Our task is to ensure that this ceremony accomplishes that objective. We need to make this ceremony a truly special event, with the highest possible level of distinguished speakers and guests from the U.S. and the Korean Governments, and the highest level of media coverage, both local, national, and international. We all need to work together from January through June to make this happen.
- Complete and Open the Korean War Memorial at the Earliest Possible Date: That is our ultimate objective, and we won't stop until we've completed our mission.

Profile of an Unusual Korean War Veteran and a Remarkable Woman: Norma V. Busse, J.D.

Norma Busse and her twin brother Norman, with whom she was always competitive, graduated from Abraham Lincoln High School in San Francisco in 1944 and went their separate ways. Norman spent a year at Stanford University before getting an appointment to the U.S. Naval Academy. Since Norman had gone to Stanford, Norma went to the University of California, Berkeley. And since Norman was going in the Navy, Norma joined the Army! At first she was a recruit with a \$50 a month salary, but later went to Officer Candidate School and was commissioned Paul Douglas and Jan Sterling as a second lieutenant.

Her second duty assignment, in 1952, was to Japan. She and Norman were briefly reunited at that time. He was serving on an aircraft carrier in Japanese/Korean waters; Norma believes it was the U.S.S. Forrestal. Then Norma got what she considered a dream job: Assistant Director of Special Services for Asia. The job entailed coordinating the USO entertainment tours for Japan and Korea. Norma and her team would welcome all the Hollywood celebrities and other entertainers, get them housing, outfit them in Army fatigues, build crates for their costumes and musical instruments, plan their itineraries, arrange for transportation, and more. Reynolds' boyfriend at the time, Norma would often then accompany the USO entertainers on their tours.

For Christmas, 1952, Norma welcomed a contingent of celebrities from Paramount, MGM, and Universal Studios. The Hollywood stars included Paul Douglas and his wife Jan Sterling, Rory Calhoun, Debbie Reynolds (still a teenager), and Carleton Carpenter, Debbie's costar (and boyfriend at the time) from their recent movie Abba Dabba Honeymoon.

A solo tour followed, featuring singer Lucy Monroe. She was known as "The Star-Spangled Soprano," because she sang the National Anthem at every New York Yankees home game.

With Norma as tour leader, Lucy and her accompanist, Army accordion player Lou Tulianello, entertained at a number of hospitals in Japan and Korea as well as hospital ships offshore.

During this tour Norma, together with Lucy Monroe and her accompanists, had the honor of meeting South Korean President Syngman Rhee and his wife for a "photo op".

An amusing sidebar: because of Norma's height (nearly 5'11"), the Koreans nicknamed her "American Woman Skyscraper"!

Among the other celebrities Norma met on USO tours were Cary Grant and his then wife Betsy Drake, Eddie Fisher (then serving in the Army), and Raymond Burr. Cary Grant and Raymond Burr visited dozens of hospitals throughout the Combat Zone. Norma recalls that Mr. Burr gave readings of poetry and scenes from well-known movies that fascinated his audiences, who gave him standing ovations. Summing up her experiences recently, Norma remarked, "This assignment was a dream job for someone on her first overseas tour of duty, and I shall never forget it."

Norma V. Busse stayed on active duty until 1973. She then went on to law school and a distinguished career as an attorney as well as a judge. She now resides in San Antonio, Texas.

Local Korean War Veterans Interviewed for Posterity By the Witness to War Foundation

On December 9 and 10, 2014, Martin Madert, Interviewer for the Norcross, GA-based Witness to War Foundation, was in San Francisco for a series of interviews with Bay Area Korean War veterans. Witness to War's mission is to preserve the stories and experiences of combat veterans. It is a 501(c)(3) nonprofit that works closely with the Library of Congress Veterans History Project. KWMF helped this organization line up interested veterans, and arranged for private interview space at the Marines' Memorial Club in San Francisco.

Each veteran's interview was recorded on video, and each veteran will soon be receiving complimentary DVD copies of his interview to keep and share with family. Commenting on this particular series of interviews, Martin Madert said, "During my trip to San Francisco, I was privileged enough to meet with six amazing veterans of the Korean War. Today, they serve as leaders of their communities and soft-spoken reminders of our nation's history." Here are the six vets who participated:

A Very Special Evening: The Remembrance Concert

Saturday, October 18, 2014 was a very special evening for our Foundation. At St. Mark's Lutheran Church in San Francisco, Ensemble Ari, a Bay Area group of classically-trained Korean musicians, presented a concert on behalf of KWMF. The musicians did not accept any payment for their work, and all the income from the concert was donated to KWMF.

About 125 donors, supporters, friends, and Korean War veterans were in attendance. The first half of the program included, in addition to classical pieces by Korean and European composers, the debut of an original composition titled Remembrance, written for baritone, piano, and string quartet by composer and Ensemble Ari Founder Jean Ahn, Ph.D. The piece was dedicated to the Korean War Memorial, in remembrance and honor of all those who lost their lives in the Korean War. Following a brief intermission, Korean War veteran and KWMF Treasurer Donald Reid welcomed the audience on behalf of KWMF, and thanked them as well as Ensemble Ari for their support.

The second half of the program then commenced with a spirited performance of Dmitri Shostakovich's Piano Quintet, Opus 57. When it ended, Ensemble Ari received a most enthusiastic response from the audience.

Ensemble Ari was founded in 2013 by Dr. Ahn. Born in the Republic of Korea, she earned her BA and MM degrees from Seoul National University and then came to the United States, where she earned her Doctorate from UC Berkeley. She has won numerous prizes and awards, and has been a lecturer at the University of the Pacific at Stockton since 2008.

"Ari" is a Korean word with several meanings: big river, wisdom, and beauty. The mission of Ensemble Ari is to build a bridge between Korea and other world communities with western musical instruments, while honoring Korean history and culture. Remembrance was Ensemble Ari's first public project.

Among Dr. Ahn's colleagues is Sarah Hong, an accomplished cellist. Ms. Hong was born in Seoul, Republic of Korea. She has been playing cello since the age of six, and was selected as the most promising young cellist in Korea at sixteen. Ms. Hong earned her BM and MM degrees from the Juilliard School, and her artist certificate in chamber music at the San Francisco Conservatory of Music. She has won numerous competitions, and has performed in Lincoln Center's Alice Tully Hall, Carnegie's Weill Hall, and the Herbst Theater.
